



Rules for Entry and Parking in the Vyšehrad National Cultural Monument Area

The Vyšehrad National Cultural Monument area operates as a pedestrian zone.

Between Táborská and Leopoldova Gates is entry permitted for service vehicles, making this section a publicly accessible area. Parking is allowed within a mixed paid parking zone and is subject to fees.

Between Leopoldova and Cihelná Gates is entry permitted for supply vehicles, taxis, liturgical ceremonies, emergency services, and the municipal police. All other vehicles require prior authorization from the Vyšehrad National Cultural Monument (NKP Vyšehrad). Two types of permits are issued. Applicants must be property owners or their tenants/residents within the NKP Vyšehrad area or owners/tenants of burial sites at Vyšehrad Cemetery.

Parking Card: A year-round or time-limited permit tied to the vehicle's license plate.

<u>Visitor Card</u>: A year-round or time-limited permit tied to the name of a legal entity.

Applications for permits must be submitted via an online form. A link to the form will be provided after contacting NKP Vyšehrad at the email address: sekretariat@praha-vysehrad.cz. The permit issuance fee is CZK 130 per permit, including replacements or changes to the vehicle's license plate.

Parking in the NKP Vyšehrad Area

Between Táborská and Leopoldova Gates:

- Reserved Parking Spaces: 4 spaces for NKPV, 4 spaces for JUŠ, 1 space for disabled persons, 1 space for No. 40/5

Between Leopoldova and Cihelná Gates (permit required):

- V Pevnosti Street: 32 spaces
- K Rotundě Street: 7 spaces (primarily for KKKV)
- Štulcova Street: 9 spaces (primarily for KKKV tenants)
- In front of the Basilica of St. Peter and Paul: 7 spaces (primarily for the church and cemetery)


Public Parking Outside Táborská Gate



Rules for Entry and Parking in the Vyšehrad National Cultural Monument Area

A pedestrian zone is an area marked at its beginning with the traffic sign "Pedestrian Zone" and at its end with the traffic sign "End of Pedestrian Zone." In a pedestrian zone, pedestrians are allowed to use the entire width of the road. Children's games on the road are not permitted in the pedestrian zone. Entry into the pedestrian zone is only allowed for vehicles specified on the bottom part of the traffic sign. Within the pedestrian zone, drivers must not exceed a speed of 20 km/h. They are required to exercise increased consideration for pedestrians, ensuring they are not endangered; if necessary, they must stop the vehicle. Parking is only allowed in areas designated as parking spaces. Pedestrians in the pedestrian zone must allow vehicles to pass.

A driver must not stop or park in a designated parking space unless the parking space is reserved for their vehicle. This rule does not apply to stops or parking of up to three minutes that do not endanger or obstruct other road users. The removal of a vehicle unlawfully parked in a designated parking space may be ordered by a police officer or a municipal police officer at the expense of the vehicle's owner.

In individual cases, and when urgently necessary, vehicles displaying a parking card for persons with disabilities may enter areas marked with the "Pedestrian Zone" traffic sign.

Unauthorized entry or parking in the pedestrian zone will be addressed by the Municipal Police in accordance with Act No. 361/2000 Coll., with a fine of up to CZK 2,000 on the spot or a referral to

For the purpose of these regulations, supply vehicles include those providing deliveries, medical, repair, maintenance, municipal, or similar services (e.g., transporting children to kindergarten) as well as vehicles transporting severely disabled persons.
